DEFINITIONS

In this Policy, definitions are as follows:

a. "University" means INDUS UNIVERSITY.

b. "Admission" means admission of the candidates in the Bachelors, Masters & Doctoral Programs

under various institute of INDUS UNIVERSITY.

c. "Institutions" means various institution of INDUS UNIVERSITY offering programmes of Engineering,

Architecture, Management, Computer Applications, Life Science and basic sciences.

d. "Website" means www.indusuni.ac.in – the Official Website of INDUS UNIVERSITY.

ADMISSIONS

Students are admitted to the various constituent Intuitions of the Indus University through Admission Committee for professional Courses (ACPC) as per eligibility criteria declared by the Regulatory Body like AICTE & Council of Architecture & admission committee of the Indus University. Admission committee of Indus university consist of Registrar of the university, Deputy General Manager- Admissions, Sr. Marketing Executive, counsellors from each department of courses. Students admitted on seats of Management Quota / PIO / Foreign Nationals / Children of Indian Workers in Gulf Countries by University on merit basis as per the guidelines of ACPC and eligibility criteria declared by the AICTE and Council of Architecture.

Admission Procedure:

Admission procedure and eligibility criteria of admission of various courses varies as per the requirement of courses or as declared by regulatory body of the courses and hence procedure is separately describing below for each courses.

B. Tech. Programmes:

Admission in First Year of all B. Tech. programme mentioned above 50% of the seats are reserved as state quota seats on which students are admitted by Admission Committee for Professional Courses (ACPC) & rest 50% seats are management quota seats on which students are admitted by concern institute of the university.

Eligibility Criteria:

- 1. Students who have passed higher secondary exam from any recognized state examination board of India with PHYSICS, CHEMISTRY AND MATHAMATICS subjects securing minimum aggregate 45% marks in all this three subjects for open category ad 40% for SC/ST category.
- 2. Students should have appeared in entrance test as GUJCET or JEE.
- 3. Students who have passed diploma in any of the engineering stream with minimum 45% for open category and 40% for SC/ST category.

Admission Procedure:

- 1. For securing admission in any engineering seat students must registered himself in ACPC and procure a merit rank given by ACPC.
- <u>State quota seats</u>: For admission on state quota seat student must apply to ACPC and follow the procedure laid down by the ACPC. Students are advised to refer following website of the ACPC for the declaration of the registration date, choice filling and counselling date. <u>https://gujacpc.nic.in/</u> <u>http://www.jacpcldce.ac.in/</u>

Once the student gets the admission on any seats of B Tech course from ACPC, he is required to report to the student's section of Indus Institute of Technology and Engineering within four working days and confirm his seat by paying the rest of the institute fees.

3. <u>Management quota seats</u>: Indus university conduct admission process on management quota seats in a fair, transparent and non-exploitative manner strictly on merit basis. For admission on management quote seats dates for sale and receive of admission form are advertised in the leading newspaper and on website of the university as per the guidelines of the ACPC.

Once applications are received within the prescribed time, a merit list is prepared on the basis of merit rank given by the ACPC & displayed on notice board of the institute and the university. Counselling for the admission on various courses of B Tech courses is conducted on a date which is already declared in the advertisement & students are offered admission on the choice of their courses as per their merit rank till the sanction seats are filled. Once the admission of any seats of students allotted is required to pay the fees to institutes to conformed his seats within four working days, otherwise admission stays canceled and that seats will be allotted to next student in the merit list.

Documents required at the time of Admissions are as follows.

- a) Self-attested Xerox of higher secondary mark sheet
- b) Self-attested Xerox of GUJCET or JEE
- c) Allotment letter form ACPC (if admission is through ACPC)

Vacant Seats:

Even after the completion of the procedure of ACPC if any seat remains vacant, those seats are given to the institution to fill up as a vacant quota seats. Indus university offers admission on vacant quota seats

on the basis of merit by advertising the vacant seats and its programme of admissions in newspaper and on website as done for the management quota seats.

Lateral Entry (Diploma to Degree) Admission in B Tech Programme

For lateral entry 10% of the seats of intake are reserved for each course of B Tech programme on which admissions are done by ACPC. There is no provision of management quota for the lateral entry. Even after the completion of the procedure of ACPC if any seat remains vacant, those seats are given to the institution to fill up as a vacant quota seats. Indus university offers admission on vacant quota seats on the basis of merit by advertising the vacant seats and it's a programme of admissions in newspaper and on website as done for the management quota seats.

Eligibility Criteria:

Diploma in any stream of engineering passed with 45% marks for open category and 40% for the SC/ST category.

Documents required at the time of Admissions are as follows.

- a) Self-attested Xerox of diploma certificate
- b) Allotment letter form ACPC
- c) Self-attested Xerox of school leaving certificate
- d) Self-attested Xerox of Aadhar card
- e) Passport size photograph- 2

M. Tech. Programme

Admission in First Year of all M. Tech programme mentioned above 50% of the seats are reserved as state quota seats on which students are admitted by Admission Committee for Professional Courses (ACPC) & rest 50% seats are management quota seats on which students are admitted by concern institute of the university.

Eligibility Criteria:

- 1 Students who have passed B. Tech/B.E. exam from any recognized university of India with securing minimum aggregate 50% marks for open category and 45% marks for SC/ST Category.
- 2 Students should have appeared in entrance test as GATE/State PGCET.

Admission Procedure:

For securing admission in M Tech seat students must registered himself in ACPC and procure a merit rank given by ACPC.

<u>State quota seats</u>: For admission on state quota seat student must apply to ACPC and follow the procedure laid down by the ACPC. Students are advised to refer following website of the ACPC for the declaration of the registration date, choice filling and counselling date. <u>https://gujacpc.nic.in/</u> <u>http://www.jacpcldce.ac.in/</u> Once the student gets the admission on any seats of M Tech course from ACPC, he is required to report to the student's section of Indus Institute of Technology and Engineering within four working days and confirm his seat by paying the rest of the institute fees.

Management quota seats: Indus university conduct admission process on management quota seats in a fair, transparent and non-exploitative manner strictly on merit basis. For admission on management quote seats dates for sale and receive of admission form are advertised in the leading newspaper and on website of the university as per the guidelines of the ACPC.

Once applications are received within the prescribed time, a merit list is prepared on the basis of merit rank given by the ACPC & displayed on notice board of the institute and the university. Counselling for the admission on various courses of M Tech courses is conducted on a date which is already declared in the advertisement & students are offered admission on the choice of their courses as per their merit rank till the sanction seats are filled. Once the admission of any seats of students allotted is required to pay the fees to institutes to conformed his seats within four working days, otherwise admission stays cancel and that seats will be allotted to next student in the merit list.

Vacant Seats:

Even after the completion of the procedure of ACPC if any seat remains vacant, those seats are given to the institution to fill up as a vacant quota seats. Indus university offers admission on vacant quota seats on the basis of merit by advertising the vacant seats and its programme of admissions in newspaper and on website as done for the management quota seats.

B.Arch Programme

Admission in First Year of B. Arch programme mentioned above 50% of the seats are reserved as state quota seats on which students are admitted by Admission Committee for Professional Courses (ACPC) & rest 50% seats are management quota seats on which students are admitted by concern institute of the university.

Eligibility Criteria:

1. Students who have passed higher secondary exam from any recognized state examination board of India with PHYSICS, CHEMISTRY AND MATHAMATICS subjects securing minimum aggregate 50% marks in all this three subjects for open category and 45% for SC/ST category OR Students who have passed diploma in any of the engineering stream with minimum 50% for open category and 45% for SC/ST category.

2. Students should have appeared in entrance test of NATA and obtain valid score as declared by council of architecture from time to time.

Admission Procedure:

For securing admission in any architecture seat students must registered himself in ACPC and procure a merit rank given by ACPC.

<u>State quota seats</u>: For admission on state quota seat student must apply to ACPC and follow the procedure laid down by the ACPC. Students are advised to refer following website of the ACPC for the declaration of the registration date, choice filling and counselling date. <u>https://gujacpc.nic.in/</u> <u>http://www.jacpcldce.ac.in/</u>

Once the student gets the admission on any seats of B Arch course from ACPC, he is required to report to the student's section of Indus Institute of Design, Environment and Architecture within four working days and confirm his seat by paying the rest of the institute fees.

<u>Management quota seats</u>: Indus university conduct admission process on management quota seats in a fair, transparent and non-exploitative manner strictly on merit basis. For admission on management quote seats dates for sale and receive of admission form are advertised in the leading newspaper and on website of the university as per the guidelines of the ACPC.

Once applications are received within the prescribed time, a merit list is prepared on the basis of merit rank given by the ACPC & displayed on notice board of the institute and the university. Counselling for the admission on various courses of B Tech courses is conducted on a date which is already declared in the advertisement & students are offered admission as per their merit rank till the sanction seats are filled. Bachelor of Design Programme

Admission on B. Des Courses_are solely performed by Indus university on the basis of merit by inviting application of the interested students by advertising the admission programme in leading newspaper

and on the website of university after the declaration of higher secondary exam result. (Normally in the month of May or June)

Eligibility Criteria:

- 1. Students who have passed higher secondary exam from any recognized state examination board of India with PHYSICS, CHEMISTRY AND MATHAMATICS subjects securing minimum aggregate 50% marks in all this three subjects for open category ad 45% for SC/ST category.
- 2. Students should have submitted portfolio of their design work and cleared entrance test conducted by the Indus University.

Documents required at the time of Admissions are as follows.

- a) Self-attested Xerox of higher secondary mark sheet
- b) Self-attested Xerox of Indus university entrance exam
- c) Self-attested Xerox of school leaving certificate
- d) Self-attested Xerox of Aadhar card

Once the admission of any seats of students allotted is required to pay the fees to institutes to confirm his seats within four working days, otherwise admission stays canceled and that seats will be allotted to next student in the merit list.

Media, Animation and Graphics Courses

Admission on Media, Animation and Graphics Courses are solely performed by Indus university on the basis of merit by inviting application of the interested students by advertising the admission programme in leading newspaper and on the website of university after the declaration of higher secondary/ graduation exam result. (Normally in the month of May or June)

Eligibility Criteria:

Students who have passed higher secondary exam from any recognized state examination board of India in any stream with 50% marks for open category ad 45% for SC/ST category.

Documents required at the time of Admissions are as follows.

- a) Self-attested Xerox of higher secondary mark sheet/Graduation certificate
- b) Self-attested Xerox of school leaving certificate
- c) Self-attested Xerox of Aadhar card
- d) Passport size photograph- 2

Once the admission of any seats of students allotted is required to pay the fees to institutes to confirm his seats within four working days, otherwise admission stays canceled and that seats will be allotted to next student in the merit list.

Integrated MBA (4 Years), Dual Degree MBA, BBA, BBA (Aviation Management), B. Com Programme

Admission on Integrated MBA, Dual Degree MBA, BBA, BBA (Aviation Management), B. Com courses are solely performed by Indus university on the basis of merit by inviting application of the interested students by advertising the admission programme in leading newspaper and on the website of university after the declaration of higher secondary exam result. (Normally in the month of May or June).

Eligibility Criteria:

- 1. For Admission on Integrated MBA, Dual Degree MBA, BBA, BBA (Aviation Management) Students who have passed higher secondary exam from any recognized state examination board of India in any stream with 50% marks for open category ad 45% for SC/ST category are eligible.
- 2. Students should have appeared in entrance test of UGAT and obtain valid score.

Documents required at the time of Admissions are as follows.

- b) Self-attested Xerox of school leaving certificate
- c) Self-attested Xerox of Aadhar card

MBA Programme

Admission in First Year of all MBA programme mentioned above 50% of the seats are reserved as state quota seats on which students are admitted by Admission Committee for Professional Courses (ACPC) & rest 50% seats are management quota seats on which students are admitted by concern institute of the university.

Eligibility Criteria:

- 1. Students who have passed graduation exam from any stream recognized university of India with securing minimum aggregate 50% marks for open category and 45% for SC/ST category.
- 2. Students should have appeared in entrance test as GCET/CAT/MAT/XMAT/.

Admission Procedure:

For securing admission in MBA seat students must registered himself in ACPC and procure a merit rank given by ACPC.

<u>State quota seats</u>: For admission on state quota seat student must apply to ACPC and follow the procedure laid down by the ACPC. Students are advised to refer following website of the ACPC for the declaration of the registration date, choice filling and counselling date.

from any recognized state examination board of India in any stream with 50% marks for open category ad 45% for SC/ST category are eligible and Mathematics as one of the subject during higher secondary.

Eligibility Criteria:

For Admission on M.Sc. (IT) Students who have passed graduation exam of BCA, BSc (Computer Science), B.Sc. (Data Science), B.Sc. (Electronics), B.Sc. (IT) from any recognized university of India with 50% marks for open category ad 45% for SC/ST category are eligible.

Documents required at the time of Admissions are as follows.

- 1. Students who have passed graduation exam from any recognized university of India in the course of BCA, BSc (Computer Science), B.Sc. (Data Science), B.Sc. (IT), with securing minimum aggregate 50% marks for open category and 45% for SC/ST category.
- 2. Students should have appeared in entrance test as GCET.

Admission Procedure:

For securing admission in MCA seat students must registered himself in ACPC and procure a merit rank given by ACPC.

<u>State quota seats</u>: For admission on state quota seat student must apply to ACPC and follow the procedure laid down by the ACPC. Students are advised to refer following website of the ACPC for the declaration of the registration date, choice filling and counselling date. <u>https://gujacpc.nic.in/</u> <u>http://www.jacpcldce.ac.in/</u>

(Physics) Courses are solely performed by Indus university on the basis of merit by inviting application of the interested students by advertising the admission programme in leading newspaper and on the website of university after the declaration of higher secondary exam result. (Normally in the month of May or June).

Eligibility Criteria:

For Admission on B.Sc. (Mathematics), B.Sc. (Chemistry), B.Sc. (Physics) Courses Students who have passed higher secondary exam from any recognized state examination board of India in any stream with 50% marks for open category ad 45% for SC/ST category are eligible.

For Admission on B.Sc. (Clinical Research) Students who have passed higher secondary exam from any recognized state examination board of India in science stream with biology as one of subject with 50% marks for open category ad 45% for SC/ST category are eligible.

Documents required at the time of Admissions are as follows.

- a) Self-attested Xerox of higher secondary mark sheet
- b) Self-attested Xerox of school leaving certificate
- c) Self-attested Xerox of Aadhar card
- d) Passport size photograph- 2

Once the admission of any seats of students allotted is required to pay the fees to institutes to confirm his seats within four working days, otherwise admission stays canceled and that seats will be allotted to next student in the merit list

M.Sc. (Clinical Research), M.Sc. (Mathematics), M.Sc. (Chemistry), M.Sc. (Physics) Courses

Admission to M.Sc. (Clinical Research), M.Sc. (Mathematics), M.Sc. (Chemistry), M.Sc. (Physics) Courses is solely performed by Indus university on the basis of merit by inviting application of the interested students by advertising the admission programme in leading newspaper and on the website of university after the declaration of graduation result. (Normally in the month of June or July).

Eligibility Criteria:

For Admission on M.Sc. (Mathematics), M.Sc. (Chemistry), M.Sc. (Physics) Courses Students who have passed graduation exam of B.Sc. (Mathematics), B.Sc. (Chemistry), B.Sc. (Physics) Courses from any recognized university of India with 50% marks for open category ad 45% for SC/ST category are eligible.

For Admission on M.Sc. (Clinical Research) Students who have passed MBBS, B.Sc. (Clinical Research), B.Sc. (Biology), B.Sc. (Chemistry), B.Sc. (Nursing), BPT, BHMS, BAMS, BDS, exam from any recognized state examination board of India in science stream with biology as one of subject with 50% marks for open category ad 45% for SC/ST category are eligible.

Documents required at the time of Admissions are as follows.

Once the admission of any seats of students allotted is required to pay the fees to institutes to confirm his seats within four working days, otherwise admission stays canceled and that seats will be allotted to next student in the merit list

CANCELLATION OF ADMISSION & REFUND OF FEES

- 1. The programme / Courses whose admissions are under the purview of ACPC, refund policy is follow as per the guidelines of ACPC/AICTE/UGC from time to time.
- 2. The programme of course where admissions are done by the Indus university refund is made as follows. If the student cancels the admission before the commencement of course or even after the 15 teaching days of the commencement of course fees paid by the students refunded by Cheque/Net transfer after deduction of Rs.1000/- administrative charge.
